❷ Passes are for the purchaser only. They are non-transferable.

❺ If pass is forgotten, you will receive one complimentary day ticket. After that, a ticket must be purchased.						
❻ Letting someone else use your pass will result in immediate loss of your season pass.						
❼ You must present your season pass to the lift attendant every time you ride the chair.						
❽ Violation of Your Responsibility Code, rude or obnoxious behavior, jumping from the chair lift, accessing areas out of the ski area boundary, etc., may result in loss of your season pass.						
❾ No refunds or credits will be issued for not picking up your season pass.						
❿ Bluewood does not guarantee the number of operating days in a season.						

I do hereby agree to RELEASE, HOLD HARMLESS, DEFEND AND INDEMNIFY WGSKI, Inc., dba Ski Bluewood; their officers, managers, coordinators, employees, instructors, agents and sponsors from all liability or responsibility for any claim or damage arising from whatever cause, including negligence, from my participation while skiing, snowboarding and other snow sports, or using any other sliding device or any use of the facilities at Ski Bluewood. I understand that there are certain risks inherent in skiing and in learning to ski; that skiing is a dangerous activity that can cause injuries. I understand and agree to assume all risks associated with skiing, including but not limited to the risk of ski equipment failure, collisions with other objects located on the mountain and lift mishaps. I hereby agree to the terms of this RELEASE and agree to assume all the risks of injury and ski at my own risk.

This release is intended to release any and all claims based on my participation while skiing, snowboarding and other snow sports or using any other sliding device or any use of the facilities at SKI BLUEWOOD, regardless of whether the claims are brought by me or on my behalf.

I understand that it is my responsibility to be aware of and to obey Washington's Skier Law RCW 79.A45 et seq. and Columbia County Washington Skier Safety Ordinance 90-4.

If I am signing on behalf of a minor, I accept full responsibility for all medical expenses incurred as a result of the minor's participation in activities or travel to and from Ski Bluewood. I also agree to HOLD HARMLESS AND INDEMNIFY Ski Bluewood from any claims of any nature brought by the minor. In addition, I hereby waive any and all claims based upon injury to the minor, including but not limited to claims for loss of consortium or companionship.

I understand that my photo or video may be used for marketing and promotional materials for the ski area.

The use of the term "skiing" also applies to snowboarding, and the use of any other sliding device or equipment.
